Art Ichihara 2018 -Spring-

The art event will be held from May 3rd (Hol) to 6th (Sun). Why don't you have extraordinary experience in Golden Week holidays? Enjoy art in beautiful greenery.

Date and time: May 3rd (Hol) – 6th (Sun), 10:00 am – 5:00 pm

Fee: 300 yen for enjoyment pass. Junior high school students or younger children are free of charge. People with physical disability certificate and their guardians are free of charge. Admission fee of Ichihara Lakeside Museum and each workshop fee will be additionally charged.

Free bus: Three routes of free sightseeing bus are available. Uchida route starts from Kazusa Ushiku Station, Loop route starts from Satomi Station, and South route starts from Tukizaki Station. Bus runs every one to two hours.

Parking space: Parking spaces are located around each place.

Garbage Collection in Golden Week Holidays

Burnable trash and recyclables will be collected as usual.

Non-burnable trash will be collected on May 10th (Thu) in the areas which is

supposed to be collected on May 3rd (Hol), and May 7th (Mon) in the areas which is supposed to be collected on May 4th (Hol).

The Rate of Light Vehicle Tax to be Reduced

Tax rate of more than three-wheeled vehicles that was examined from April 2017 to March 2018 will be reduced only in the fiscal year of 2018 (See a chart below). Besides, if it passed 13 years since vehicles had received initial examination, the vehicle tax will be heavily charged from the fiscal year of 2019 as a chart below.

My Number is required for Reduction of and Exemption from Tax

Those who have physical disability certificate, etc. and whose living expense is same with them may be able to get reduction of or exemption from light vehicle tax.

Period of acceptance of the application: April 20th (Fri) – May 31st (Thu)

How to apply: Apply at the counter of Tax Division with the following

documents.

- Certificate of physical disability, etc.
- Driver's license of a person who drive for a person with physical disability
- Vehicle inspection certificate
- Tax notice
- Inkan (seal)
- Document to check My Number (Individual Number)
- Certificate of same living expenses ("Seikei Douitsu Shomeisyo") or "Kitaku Shomeisyo" (if a person with physical disability doesn't live with the driver.)
- Letter of proxy (if a proxy will apply.)

Warning of photochemical smog

It is a time to pay attention to photochemical smog from April to October. When warnings for photochemical smog are issued, go inside and prevent health damage.
